ELIGIBILITY

HOW TO ENTER

All entries must be received by June 11, 2025, at 1:00 p.m. EST to be eligible. There is no limit on entries per eligible person.

PRIZE DRAWING

ESTIMATED ODDS OF WINNING

Actual odds of winning are dependent upon the total number of eligible entries. There are 1,000 total raffle tickets available for purchase.

PRIZE

There will be one prize for this Raffle. Winner will receive one 2025 Toyota Corolla Hybrid LE valued at \$27,998.00. No substitutions, reassignments, or transfers of the prize are permitted. Winner may select and add options at his/her cost. The color of the vehicle is the winner’s choice. The prize is subject to availability.
